North Carolina Department of Revenue requires vendors to obtain a certificate of registration to sell products not from their farm or reselling of items. Farmers selling their own farm products do not require registration, but they are required to provide a signed agreement stating they are omitted from the new regulation to keep on file with the Market Manager. If you are a vendor required to certify you must collect the appropriate tax and register with NCDOR. The Market Manager is still required to keep a daily registration list of vendors.

\*\*Opening date for Salisbury Farmers Market is Saturday, April 14, 2018

\*\* April 14 to August 25-- Saturdays

• Saturday market time 8 a.m. to 12 noon

Fall/Winter Market Hours: September 2 to December 22 -9:00 a.m. to 12 noon

\*\*Salisbury Farmers Market fees:

- There is an annual membership fee of \$25.00.
- The daily space rental is \$12.00 on Saturdays and \$20.00 for non-members.
- Pre-payment rates for 2018: 10% discount for summer pre-payers, 10% discount for fall pre-payers, and 15% for those who commit to the entire season. Summer = \$240 24 = \$216. Fall= \$204 20 = \$184, Full year = \$375 (with 15% discount). All discounted rates need to be paid on the first day of the market (s). (summer and full year due on April 14). (fall due on September 1)
- The annual membership fee will be used to cover expenses for maintaining the website, weekly newsletter, promotional activities and advertising.
